Thoughts from Ian...

Sometimes we just go too far.
Recently, I was reminded of this while watching
Samuel learn how to throw

things away in the trash can. He has seen Alissa and me throw trash away countless times and now believes it is time for him to join in on the game. He has grown enough to reach the lid of the trash can, open the lid, and toss in whatever is in his hand. The problem is he throws anything and everything away. Spoons, keys, straws, and more have been happily tossed by our playful boy. Of course, many of these items are not appropriate to throw away and so his mom and I need to dig these items out of the trash. Even though the keys may be covered in trash and gunk, they must be recovered! And we hope that Samuel is watching our correction.

At times, we can be like Samuel. People can be too quick to 'throw things away". We are too quick to discount people. We give up hope on situations and think that they are too far gone. We sin, fail, and make mistakes and toss them in the pile of unredeemable things. I look at the brokenness of the world and I know that I am too weak to fix much or any of it. I am happy to throw things away and move on to easier tasks and "easy to get along with" people.

But God is like a wise parent who looks through my pile of unredeemables and restores what I have so easily discarded. God is a redeemer, especially of people. Ro-

mans 3:23-24 says that all have sinned and all who are saved are redeemed freely and graciously by Jesus. Jesus

is the Redeemer of his people. In Psalm 111:9, the Psalmist praises God's redeeming of his people through the covenant. God is a redeemer of people.

God is also a redeemer of our circumstance. I am sure that many of the Israelites who were slaves in Egypt felt discarded and forgotten, but God redeemed them and their circumstance (Exodus 6:6-8). God does not only pull them back into a relationship with him (I will take you as my own people and I will be your God) but he redeems their situation (I will bring you to the land I swore). God can redeem our lives as well. And he hopes we are watching.

God hopes we are watching because he wants us to have hope. Confidence in the fact that God can redeem us and the people in our lives. Confidence that he can bring good out of bad situations. He wants us to have hope in him. Also, God hopes we are watching because he wants us to participate in redeeming people and circumstances. In James 5:13-20, he reminds us of two ways we can participate. First, we can pray. In prayer, we partner with God and ask him to redeem. Second, he reminds us to restore those who have wondered from the truth. We partner with God in redeeming people when we lead them back to THE Redeemer. Let's not be people who go too far in discarding people and circumstances. Instead, let's put our confidence in the Redeemer and partner with him to bring redemption in the world.

And if you ever see Samuel near a trash can at church, you may want to check to see if he has thrown anything away and, if he did, if it is something that needs to be rescued from the trash.

Session Highlights May

At the May 15th Session meeting, elders:

*heard from Pastor Ian that he will be <u>adding staff/</u> <u>leadership bio's</u> to the "about us" area of the website; that he is testing some better <u>music videos</u> for contemporary songs at the beginning of worship; and that he received an <u>EPC scholarship</u> for part of his expenses to attend General Assembly in Tennessee in June. The remaining expenses will be covered 50% from his Continuing Ed fund and 50% from Miscellaneous, with discussion of adding the annual expense to the church budget going forward.

*were encouraged to think of couples who might want to attend a "Family Life Weekend to Remember Marriage Getaway" offered in October2018/November 2018/Feb 2019 in Dayton/Detroit/Cincinnati. All expenses including tuition and motel would be covered by a Ministerial Fund held within the Paulding Co Area Foundation. If you are interested or have a suggestion, speak to Pastor Ian.

*learned that the Property committee will schedule a workday probably June 23 or 30 for upkeep that needs to be done around the building. All hands on deck makes light work! Also, no replacement of the ignitors on a kitchen range will be done, as the expense outweighed the benefit. This committee will also review our current status as a Red Cross Emergency Disaster site and whether information is current.

*heard that a decision whether to schedule <u>boiler</u> replacement or to take our chances with fingers crossed for another winter needs to be made, as work would need to be scheduled by August. Cost is in the \$35,000 range for total replacement, and donations are being sought.

*put off further discussion of the idea of a <u>play-ground</u> area, until at least after the boiler replacement is dealt with.

*thanked Stan Searing for updating the cottage tax status with the County Auditor now that it is being used completely as a residence. In years past, the 'conference room' (only) was considered tax-exempt. The change in the property tax bill should be minimal and will appear in 2019, when 2018 taxes are due.

*joined Friends of the Chamber for \$100. This is the parent group of CoRP, which is working on Downtown Revitalization and the potential creation of an historic zone that would include our church.

*tossed around the idea of using our prime location during the 127 Garage Sale August 2-5. Possible ideas were to rent spaces in the lot; offer food and cooling in the Fellowship Hall; provide a baby changing/nursing area; etc. Questions would include liability, staffing, what to charge, etc. Funds could be used toward instituting a Mission trip (a Pastor Ian dream!), or to support future Women's Retreats. No decision was reached. If this idea is of interest to you, please talk to Pastor Ian or Barb Searing.

Sad, angry, resolute: thoughts from a Turkish courtroom

Sad, angry, and resolute.

These are my states of mind as I wake after Andrew Brunson's trial. After 10 hours in court, I am deeply saddened that the judge refused to allow Andrew's request to return home and finish the trial under some form of house arrest. I'm sad at having to watch Norine be brave yet again for her husband and community. She is like Mary pouring her treasure out at Jesus' feet. It's her costly treasure of time, lost time with husband and children, her father's death, and so much more. I'm also sad for the Turkish people and the blatant miscarriage of justice. This bleeds into my anger.

The judge allowed the most ludicrous witnesses to testify against Andrew. One young man, who had angrily left their church years ago, wanted to return to the church but was denied membership because he was such a troublemaker. He refused to repent. On the stand, this man admitted to creating a fake Facebook page in Andrew's name and posting pro-terrorist items on it. The judge looked passed this and validated this man's testimony of seeing terrorist flags in Andrew's church. It was a total lie, but the judge said it carried weight. The judge not only led witnesses with his questions, but also linked all the witnesses at the end in an effort to maintain the case against Andrew. The most angering blow was at the end when the judge decimated Andrew's witness defense list saying that most of his witnesses were also "suspects" and, therefore, could not testify on Andrew's behalf. This, in effect, ties the hands of Andrew's defense.

So, what to do with unresolved sadness and justified anger? This morning I am reflecting on 1 Peter 2:23—"When he was reviled he did not revile in return, when he suffered (unjustly) he did not threaten, but continued entrusting himself to Him who judges justly." Also, Psalm 30:5— "Weeping endures for the night but joy comes in the morning." And Romans 12:12—"Rejoice in hope, be patient in tribulation and constant in prayer."

God did answer many prayers. Andrew spoke with clarity, authority, and boldness in the Lord as he refuted many, many lies spoken against him. Norine remained strong and alert. I had asked the Lord to be able to get into the courtroom. We got in. I asked to be a visible encouragement to Andrew and to have five minutes to visit with him. Everyone assured me that it would be impossible. No clergy of any faith have visited prisoners during this state of emergency in Turkey. BUT...then there was a technical difficulty with the jumbotron screens and while all were distracted, Andrew turned around in his seat and looked back at us as we sat in the back of the court. Norine said that this was not allowed. But with the judges distracted with the screen, Andrew was able to lock eyes with Norine and me and Sam and several others. I was able to communicate love, prayers, and blessings. It was a sacred and joy-filled moment from the Lord. We all wept. This technological difficulty lasted five minutes. It happened again later so we got another opportunity for eye—to-eye, loving contact. When Andrew was escorted out of the courtroom I moved to a place closer to his exit door and yelled out, "We love you, brother. We will never forget you. The whole church is praying for you back home."

Joy, sorrow, anger, and resolution.

I remain resolute in standing with and praying for Andrew. I know you do as well. Hebrews 13:5 says, "Remember those in prison as though with them." So we must keep praying. God is working something much larger than we can see or understand right now. I assured Norine and Andrew (in a note I left for Andrew with the U.S. consular) that our church is praying for them, even at 2:00 a.m. in Graham Chapel.

Thank you for praying. This is the hard work God has for us. Romans 15:30 says, "I appeal to you brothers and sisters by our Lord Jesus Christ and by the love of the Spirit to strive together with me in your prayers to God on my behalf, that I may be delivered."

You will continue to give receive updates on Pastor Andrew until our prayers are answered and he is home.

The second event for June is lunch Monday June 18th at Fiesta Habaneros, noon. No reservations required, just come.



By the first of June, we will have the full schedule printed into a flyer for the women of the church to have for reference. For now, put June 6th and June 18th on your calendars.



In April we:


- Received a reimbursement check of \$269.19 for the cost of replacing a coffee maker that was damaged in the fire suppression incident.
